The Contractor further undertakes to arrange insurance to cover for:

- a.) Employers liability for a minimum of ten million pounds;
- b.) Third party liabilities, including all servants, contractors and agents involved with a BMI UK & Ireland roof project for a minimum cover of two million pounds;
- c.) Contract works for the value of the completed works.

A public, product and employers liability insurance certificate must be supplied to BMI UK & Ireland on an annual basis.

All claims will be subject to independent arbitration.
